How U.S. taxpayers can donate funds to a Bermuda charity (Reference the Ocean Support Foundation):

All donations must be accompanied by a letter of intent addressed to the International Charitable Fund of Bermuda, Inc. (See Sample Letter Of Intent below)

1. By Cheque

A donation can be made by cheque drawn either on a Bermuda or foreign bank. The cheque made payable to ICFB, Inc., must be denominated in U.S. or Bermuda Dollars.

2. By Capital G Internal Bank Transfer

U.S. taxpayers that have accounts at Capital G may make an internal bank transfer by selecting the International Charitable Fund of Bermuda, Inc. from the Capital G pick list on the bill pay function. Once the transfer is complete, a letter of intent should be sent to the ICFB, Inc.

3. By Bermuda bank Transfer

U.S. taxpayers holding accounts at a Bermuda bank may transfer funds to one of the two ICFB, Inc. bank accounts as follows:

BMD savings: 4010912634

USD savings: 6000071174

Once the transfer is complete, a letter of intent should be sent to the ICFB, Inc.

4. By International Wire
